WHEREAS, the lowest bid from R&S Overhead Garage, Inc., should be rejected because the bidder was deemed non-responsive by their failure to submit a bid bond; and

WHEREAS, the second low bidder, Wah Mei Construction Company, is the lowest responsible bidder and has met the City's LBE/SLBE program requirements; and

WHEREAS, there are sufficient funds of \$295,000 in the project budget for the work; and

WHEREAS, the City lacks the equipment and qualified personnel to perform the necessary work; and

WHEREAS, the City Council finds and determines that the performance of this contract is in the public interest because of economy; and

WHEREAS, the City Council finds that services under this contract will be temporary; and

WHEREAS, the City Council finds and determines that the performance of this contract shall not result in the loss of employment or salary by any person having permanent status in the competitive service; now, therefore, be it

RESOLVED: That the City Manager, or her designee, is hereby authorized to award a construction contract on behalf of the City of Oakland for the Mosswood, F.M Smith, and Dimond Recreation Center Kitchen Renovations project to Wah Mei Construction Company in the amount of Two Hundred Ninety-Five Thousand Dollars (\$295,000) and to execute any amendments or modifications of said contract within the limitations of the project specifications; and be it
