## RESOLUTION AUTHORIZING SUBMITTAL OF AN APPLICATION TO THE CALIFORNIA INTEGRATED WASTE MANAGEMENT BOARD FOR A LOCAL GOVERNMENT WASTE TIRE EDUCATION AND AMNESTY DAY GRANT FOR FISCAL YEAR 2003-2004 IN AN AMOUNT UP TO \$20,000, AND ACCEPTANCE AND APPROPRIATION OF FUNDS

WHEREAS, Senate Bill 876 (Escutia, Statutes of 2000, Chapter 838) authorizes the California Integrated Waste Management Board to establish a grant program to provide opportunities to divert waste tires from landfill disposal, prevent illegal tire dumping, and to promote markets for recycled-content waste tire products; and

WHEREAS, the California Integrated Waste Management Board has been delegated the responsibility for the administration of the program within the State, setting up necessary procedures governing application by California cities, counties, city and county, special districts or political subdivisions thereof, and Federally recognized California Indian tribes; and

WHEREAS, the City of Oakland is implementing waste tire enforcement activities to reduce illegally dumped waste tires from commercial sources with funding from two previous CIWMB Waste Tire Enforcement Grants, and wishes to use CIWMB grant funds to also reduce residential sources of illegally dumped waste tires; and

WHEREAS, said procedures established by the California Integrated Waste Management Board require the applicant to certify by resolution approval of the application before submission of said application to the State; and

WHEREAS, if awarded a grant, the City of Oakland will enter into an agreement with the State of California for development of the project;

NOW, THEREFORE, BE IT RESOLVED that the City Manager or his designee as agent of the City of Oakland is hereby authorized to submit an application to the California Integrated Waste Management Board for the Local Government Waste Tire Education and Amnesty Day Grant Program for FY 2003/2004, and be it

FURTHER RESOLVED, that the City Manager or his designee as agent of the City of Oakland is hereby authorized to execute and submit all documents, including, but not limited to, applications, contracts, payment requests, agreements and amendments to implement the activities specified in CIWMB Local Government Waste Tire Education and Amnesty Day Grant Program for FY 2003/2004 application, and that such activities will be reported to and processed with the City Manager's office in accordance with all relevant City of Oakland fiscal management regulations and procedures, and be it

FURTHER RESOLVED, that the City Manager or his designee as agent of the City of Oakland is hereby authorized to appropriate grant revenues and expenditures to the Community and Economic Development Agency, Building Services, after receipt of a Local Government Waste Tire Education and Amnesty Day Grant for FY 2003/2004.
