

### CES BUTNER BIOGRAPHY

Businessman Ces Butner is President/CEO/Owner of Horizon Beverage Company, an Oakland based beverage distributorship that supplies retailers in Northern Alameda County and Western Contra Costa County.

After graduating from the University of Missouri in 1975 and working in Minneapolis and Chicago for fortune 500 Companies, Butner settled in Oakland in 1981, working for a local beverage distributorship. Beginning as Sales Manger, he also held the positions of General Manager and Vice President when, in 1987 at the age of 33, he purchased the business with business partner Denny Suzuki, naming it Horizon Beverage Company and becoming the youngest owner of an Anheuser-Busch Wholesale Operation in the nation. Horizon is now recognized by Anheuser-Busch as one of its outstanding distributors having won the coveted Ambassador Award (the top distributors in the nation) for six years in a row. Mr. Butner has served on the board of the NBWA (National Beer Wholesalers Association), CBBD (California Beer Beverage Distributors), and currently serves on Anheuser Busch's "Wholesale Advisory Panel" and Crown Imports' "Wholesaler Council". Through acquisitions and expansions over the last 25 years Butner has more than tripled the size of Horizon Beverage Company revenues placing it among Black Enterprise's top 100 Black Owned Business nationally. Horizon employs more than 150 families and is the only labor friendly (Teamster Local 853) beer distribution operation in the East Bay.

Ces Butner has long been involved with the Oakland conununity. He has been Chairman of the Board of the YMCA of the East Bay, the Oakland Metropolitan Chamber of Commerce, and President of Sequoyah Country Club. He has also served as Co-Chair of Friends of Oakland Public Schools and Board member with Oakland Rotary #3, the City of Oakland's Budget Advisory Board, the Oakland Education Council, Bay Area Black United Fund, Lake Merritt Breakfast Club, Oakland Convention and Visitors Authority, Oakland Commerce Corporation, Redwood Day School, and Oakland Festival of the Arts. As Chairman of the Oakland Metropolitan Chamber of Commerce, Ces led the charge for the adoption of City Center revitalization plan and the creation of the Business Budget Advisory Committee to build the necessary link between city government and the business community. Butner was also a candidate for Mayor of Oakland in 1998 losing to former and current Governor Jerry Brown.

Mr. Butner's interest in public service is a continuation of his efforts to utilize business principles to promote equal opportunity, economic development, entrepreneurship, education, and environmental responsibility for all the citizens of Oakland. He is committed to preaching the gospel of efficiency and accountability in government, as well as economic development as a means to success for Oakland and its residents.

Mr. Butner lives in Oakland with his wife Teresa and two daughters Raquel & Andrea while working out of his warehouse and offices in West Oakland. Mr. Butner remains committed to Oakland as Horizon is currently constructing a new facility in East Oakland.

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Article Vil, Section 701 of the City Charter, as amended by Stats., November 1988 creates the Board of Port Commissioners to set policy for and govern the activities of the Port of Oakland, appointing is own Executive Director and approving its own budget and promoting and insuring the comprehensive and adequate development of the Port of Oakland through continuity of control, management and operation, and

WHEREAS, the Board of Port Commissioners consists of seven (7) members serving 4-year terms, who are nominated by the Mayor and appointed by Council, and who must be residents of the city of Oakland, having resided in Oakland for one year prior to appointment; and

WHEREAS, the Honorable Mayor Libby Schaaf has reappointed Ces Bunter to the Board of Port Commissioners, subject to confirmation by the City Council, to serve a four year term beginning July 11, 2015 and ending July 10, 2019, filling the seat previously held by himself; and the appointment of Joan Story to the Board of the Port Commission, subject to confirmation by the City Council, to serve a four year term beginning July 11, 2015 and ending July 10, 2019, filling the seat previously held by Victor Uno now therefore be it

**RESOLVED:** That pursuant to City Charter section 601, the City Council hereby confirms the Mayor's reappointment of Cestra Butner to a four-year term on the Board of Port Commissioners beginning July 11, 2015 and ending July 10, 2019, filling the seat previously held by himself. and the appointment of Joan Story to a four year term on the Board of the Port Commission
