INTRODUCED BY COUNCILMEMBER _____

RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE CONTRACTS BETWEEN THE CITY OF OAKLAND AND THIRTY-SEVEN (37) CHEMICAL DEPENDENCY TREATMENT PROGRAMS, MENTAL HEALTH THERAPISTS AND MANAGEMENT COACHES TO PROVIDE SERVICES UNDER THE CITY'S SELF FUNDED CHEMICAL DEPENDENCY AND MENTAL HEALTH BENEFIT FOR THE FISCAL YEARS 2000-2003, IN AN AMOUNT NOT TO EXCEED \$150,000 ANNUALLY.

Whereas to City of Oakland is committed to maintaining a drug free workplace; and

Whereas the City of Oakland authorized the EAP to establish and use a preferred provider panel to meet the needs of its employees for chemical dependency and mental health treatment at present benefit levels,

Whereas the City has agreed to provide chemical dependency treatment for unrepresented employees for Local 55, Local 790 and Local 21, and

Whereas the City is committed to provide the resources to enable managers and supervisors to develop their management skills through the provision of management coaching,

Whereas, contracts requiring professional or specialized services are exempt from competitive bidding pursuant to Section 5(I)(1) of Ordinance No. 7937 C.M.S. and

Whereas the City Council finds that the services under these contracts are temporary and

Whereas the City Council finds that these contracts are for services of a professional nature; and

Whereas, the City Council finds that these contracts shall not result in the loss of employment or salary by any person having permanent status in the competitive civil service, and

Whereas the City wishes to enter into agreements with the following thirty-seven preferred providers, to be used on an as-needed basis. in maximum amounts as indicated below:


