

## OAKLAND CITY COUNCIL

Resolution No. 84556 C.M.S.

INTRODUCED BY COUNCIL PRESIDENT PATRICIA KERNIGHAN

**RESOLUTION DESIGNATING VICE MAYOR LARRY REID AS THE CITY OF OAKLAND'S VOTING DELEGATE AND COUNCIL MEMBER NOEL GALLO AS THE CITY OF OAKLAND'S ALTERNATE VOTING DELEGATE TO THE NATIONAL LEAGUE OF CITIES' ANNUAL BUSINESS MEETING, SCHEDULED TO TAKE PLACE IN SEATTLE ON NOVEMBER 16, 2013**

**WHEREAS**, the City of Oakland is a Member City of the National League of Cities; and

**WHEREAS**, the Rules for Conduct of the National League of Cities, Section 4.2 states: "Designation and Certification of Voting Delegates and Alternates - Prior to the Annual Business Meeting, each member city shall designate one voting delegate and may designate one first alternate and one second alternate to cast the city's vote or votes at the Annual Business Meeting"; and

**WHEREAS**, the City Council's Rules of Procedure (Resolution No. 82580 C.M.S.) state that "the President of the Council shall recommend appointments to regional and local boards and agencies, as appropriate, subject to confirmation by the Council"; and

**WHEREAS**, the Council President wishes to appoint Vice Mayor Larry Reid as the City of Oakland's Voting Delegate to the National League of Cities' 2013 Annual Business Meeting, and wishes to appoint Noel Gallo as the City of Oakland's Alternate Voting Delegate to the National League of Cities' 2013 Annual Business Meeting; now, therefore be it

**RESOLVED:** That Vice Mayor Larry Reid is hereby appointed as the City of Oakland's Voting Delegate to the National League of Cities' 2013 Annual Business Meeting; and be it

**FURTHER RESOLVED:** That Councilmember Noel Gallo is hereby appointed as the City of Oakland's Alternate Voting Delegate for the National League of Cities' 2013 Annual Business Meeting.


