Pursuant to Section 401 of the Charter, the City Attorney has prepared and recommends settlement of the above-entitled matter arising from an incident on May 10, 2002, in which plaintiff tripped and fell on a portion of upraised concrete that abutted an EBMUD utility box in the sidewalk.

Due to the risk of an adverse jury verdict under the circumstances, settlement is recommended in the amount of Seven Thousand Five Hundred Dollars and No Cents (\$7,500.00), to be made payable to Ruth E. Abrams and William J. Petzel, Esq., her attorney of record.
