## **RECOMMENDATION**

Staff recommends that City Council adopt:

A Resolution Waiving the City's Advertising, Competitive Bid and Request for Proposal/ Qualifications (RFP/RFQ) Process And Authorizing A Professional Services Contract With Keyser Marston and Associates, Inc., In An Amount Not To Exceed \$250,000 To Provide Economic Consulting Services To The City For The Coliseum City Project, With An Option To Add An Additional \$50,000

## REASON FOR THE SUPPLEMENTAL REPORT

At the April 28th Community and Economic Development Committee meeting, President McElhaney requested staff to provide information regarding a tally on the amount of funds that have been invested on the Coliseum City project since 2013. However, staff is providing information dating back to 2012, since the project officially started during that year.

In addition, the majority of amounts represented (*Table-1*) in the following table were paid for utilizing restricted Coliseum bond funds. Staff is currently proposing to continue using Coliseum TA Bond Series 2006B-T, restricted bond funds for the new KMA professional services contract.
