RESOLUTION NO. 88740 C.M.S.

RESOLUTION AUTHORIZING THE CITY ADMINISTRATOR TO AMEND THE GRANT AGREEMENT WITH DOWNTOWN STREETS TEAM FOR A WORKFORCE AND EMPLOYMENT PLACEMENT PROGRAM TO EXTEND THE GRANT TERM END DATE TO JUNE 30, 2022

WHEREAS, the Oakland City Council adopted resolution No. 88109 on May 12, 2020 which, among other things, authorized the City Administrator to award grants in amounts up to \$1 Million through June 30, 2021 to homeless service providers to be selected through the Human Services Department's (HSD) Request for Qualifications (RFQ); and

WHEREAS, as a result of said City Administrator authority and HSD's RFQ process, the City Administrator accordingly awarded a grant to Downtown Streets Team (DST) for a term of July 1, 2020 to June 30, 2021, in an amount not to exceed \$750,000, to provide workforce development and employment placement for unhoused people in Oakland; and

WHEREAS, due to logistical challenges exacerbated by the COVID-19 pandemic, DST would not be able to begin service delivery until Fall of 2021; and

WHEREAS, DST is currently on-track to meet or exceed the deliverables outlined in the current scope of work, if the grant term is extended; and

WHEREAS, City staff is seeking the authority to extend the grant award term end date and agreement end date with DST from June 30, 2021 to June 30, 2022, in order to continue this previously delayed work; now therefore be it

RESOLVED: That the City Council authorizes the City Administrator to extend the grant award term end date and authorizes the City Administrator to extend the grant agreement with DST through June 30, 2022; and be it

FURTHER RESOLVED: That the City Administrator is authorized to conduct all negotiations; execute and submit all documents, including but not limited to applications, agreements, amendments, modifications, payment requests; and to take related actions necessary for the above-referenced agreement, without returning to Council; and be it

FURTHER RESOLVED: That said grant amendment shall be reviewed as to form and legality by the Office of the City Attorney and executed copies of the same shall be filed with the Office of the City Clerk.


