WHEREAS, Officer Pamela Williams has worked in Patrol, Youth Services Section, as an Intake Officer, and Juvenile Investigator, and was a D.A.R.E. Officer for 3 years, as well as the Police Cadet Coordinator for 3 years, and;

WHEREAS, Officer Pamela Williams loved working with young people, first volunteering for PAL as coach of the girls' handball team 26 years ago, and continued to volunteer countless hours to PAL and was officially assigned to PAL in 2001, where she has coached basketball teams, camps and leagues; coordinated the summer overnight camp for youth; and ran the PAL programs, "Just For Girls", and "Hoops For Education", and;

WHEREAS, Officer Pamela Williams, after 28 years, is officially hanging up her gun-belt and badge to retire from the Oakland Police Department and will continue to volunteer and mentor the youth in Oakland, now therefore be it
