To the Members of The City Council;

As President of the Council i withdraw from the December 20, 2011 Council agenda the resolution under item 7.7 appointing Councilmembers De La Fuente and Brooks to the Oakland-Alameda County Coliseum Joint Powers Authority Board (Board). These councilmembers were appointed to the Board on February 1, 2011, pursuant to Resolution No. 83177 C.M.S. The 1996 Oakland-Alameda County Coliseum Joint Powers Authority Agreement established two-year terms for Board seats. The current councilmember terms will end on January 20, 2013. Because Councilmembers De La Fuente and Brooks are midterm, appointment to the councilmember Board seats is not appropriate at this time.

However, I wish to proceed with the resolution under the same Item 7.7 re-appointing Yui Hay Lee and appointing Aaron Goodwin to the community member seats on the Board for two-year terms beginning October 9, 2011 and ending on October 8, 2013.
