#### NOTICE AND DIGEST

**AN ORDINANCE TO ENACT THE UNIFORMS RESIDENTIAL TENANT RELOCATION ORDINANCE TO (1) ESTABLISH AN UNIFORM SCHEDULE OF RELOCATION PAYMENTS; (2) TO EXTEND RELOCATION PAYMENTS TO TENANTS DISPLACED BY OWNER MOVE-IN EVICTIONS; (3) TO EXTEND RELOCATION PAYMENTS TO TENANTS DISPLACED BY CONDOMINIUM CONVERSIONS; AND (4) CONFORM EXISTING ELLIS ACT AND CODE COMPLIANCE RELOCATION AMOUNTS TO THOSE IN THE UNIFORM SCHEDULE**

The Ordinance enacts the Uniform Residential Tenant Relocation Ordinance to establish a uniform schedule of relocation payments for no-fault evictions; extend relocation payments to tenants displaced by owner or relative move-in evictions; and extend relocation payments to tenants displaced by condominium conversions.
