BACKGROUND:

Assemblywoman Loni Hancock has convened a group of eight cities (from Oakland to Pinole) and seven regional agencies to discuss joint planning to preserve and enhance the corridor into a revitalized mixeduse transit corridor. The group will build on past collaborative successes, such as AC Transit's 72R Rapid line and SMART Corridors (the advanced transportation management system along San Pablo Avenue), and will also retain current residents and local businesses. Each city involved in this effort will benefit from neighboring cities' ideas, experiences and projects. While each jurisdiction will maintain its authority and individuality, the collective group may be able to secure resources that are not readily available to individual cities. With the support of the cities along the corridor, the group will begin to involve the larger community, including residents, merchants, developers, environmentalists and many others.

FINANCIAL IMPLICATIONS:

None at this time. Limited staff in order to share data and ideas.

RECOMMENDATION:

We recommend that City Council endorse the concept of regional planning for San Pablo Avenue, and designate a representative to this regional planning initiative.
