Resolution Approving The Traffic Signal Priority List And The Pedestrian Priority Signal List For The Top Ten (10) Intersections Citywide, Pursuant To

City Council Resolution No. 78747 C.M.S.

SUMMARY

At their September 25, 2007 meeting, the Public Works Committee requested that staff modify the resolution to specifically reference Attachments A and B to the report and to note which intersections are to be funded under the adopted 2007-2009 budget. The revised resolution is attached.

The Committee also requested that staff consider including additional criteria in determining signal need, including proximity of an intersection to senior facilities and school areas.

BACKGROUND

As part of the City's ongoing efforts to improve safety and move people and goods efficiently on its road system, staff regularly evaluates the need for signals at intersections in response to requests from the public. Following council's policy directives, the installation of signals has proceeded under two distinct programs. One addresses the general need to improve safety and circulation, and the second to improve pedestrian safety. In each program, locations are ranked using objective criteria that include traffic and pedestrian volumes and accident data.

KEY ISSUES AND IMPACTS

The Public Works Committee requested that staff discuss how the presence of senior citizens and school age children can be considered in the prioritization of traffic signals.

Since 2003, the Transportation Services Division of the Community and Economic Development Agency has requested and received funding from the City Council for a Safe Routes to School program. The City has also been successful in competing for state and federal grants specifically earmarked for school safety that further leveraged these funds. Together, this has resulted in approximately \$2 million of traffic safety improvements around Oakland schools. Staff recommends that funding for this program be continued in future city budgets.

Given the long list of identified locations that require signalization to address existing traffic safety problems, Council may wish to consider a program similar to the existing Safe Routes to School program, dedicated to improving pedestrian safety near senior centers.

In addition, staff will continue to explore grant opportunities that address senior safety, and ways to identify locations that are adjacent to senior centers future priority lists, for council consideration.

RECOMMENDATION AND RATIONALE

Staff recommends proceeding with the design and installation of traffic signals at the following intersections from Exhibit "A": Seminary Avenue/Avenal Avenue; International Boulevard/50th Avenue; Fruitvale Avenue/School Street; and Foothill Boulevard/34th Avenue. The Foothill Boulevard/34th Avenue location is recommended at this time, because it also appears as #2 on the pedestrian signal list.

Further, since the intersection of International Boulevard/81st Avenue has a score identical to the location at Foothill Boulevard/34th Avenue, staff will initiate discussions with Caltrans to install a signal at this location, since International Boulevard is a state route east of 42nd Avenue. Similarly, staff will bring Caltrans to the table to discuss the 2nd ranked location at International Boulevard/50th Avenue in order to leverage city funds.

For the pedestrian signal program, staff recommends proceeding with the following locations from Exhibit "B": International Boulevard/36th Avenue and the High Street/Porter Street intersections. The High Street/Porter Street location is recommended over International Boulevard/26th Avenue at this time because signals have been installed at both 25th and 27th Avenues in the last five years.

RESOLUTION APPROVING THE TRAFFIC SIGNAL PRIORITY LIST AND THE PEDESTRIAN PRIORITY SIGNAL LIST FOR THE TOP TEN (10) INTERSECTIONS CITYWIDE, PURSUANT TO CITY COUNCIL RESOLUTION NO. 78747 C.M.S.

WHEREAS, the residents and the general public request traffic and pedestrian signals at many intersections citywide; and

WHEREAS, staff periodically evaluates requests for traffic and pedestrian signals and assigns points according to the City's signal warrant and priority system pursuant to the City Council Resolution No. 78747 C.M.S., as well as a ten-year pedestrian accident history; and

WHEREAS, over 300 intersections exist on the signal need priority list; and

WHEREAS, the top 30 intersections have been recently evaluated and ranked; and

WHEREAS, the top 10 intersection have been identified as candidates for considerations for signalization for the Fiscal Years 2007-2009; now, therefore be it

RESOLVED: That the lists of the top ten intersections needing traffic signals and pedestrian signals are hereby adopted, as Attachments A and B; and be it

FURTHER RESOLVED: That the Community and Economic Development Agency, Transportation Services Division, is directed to implement the top four traffic signal locations:

- Seminary Avenue at Avenal Avenue
- International Boulevard at 50th Avenue
- Fruitvale Avenue at School Street
- Foothill Boulevard at 34th Avenue

and the top two pedestrian signal locations:

- · International Boulevard at 36th Avenue
- · High Street at Porter Street

as budgeted in the adopted 2007-2009 policy budget; and be it

present to the City Council a prioritized list of locations identified for traffic or pedestrian signals for funding and implementation.
