**NOTICE AND DIGEST
ORDINANCE AUTHORIZING A FISCAL YEAR
2015-16 INCREASE TO A SPECIAL TAX IMPOSED
FOR PARAMEDIC EMERGENCY SERVICES, IN
ACCORDANCE WITH THE CONSUMER PRICE IN-
DEX, AND PURSUANT TO THE 1997 PARAMEDIC
SERVICES ACT (MEASURE N)**

This Ordinance would authorize an increase of the special tax imposed for paramedic emergency services pursuant to Measure N for Fiscal Year 2015-2016 in the amount 2.8%, which represents the cost-of-living increase based on the San Francisco Bay Area Consumer Price Index from calendar year 2013 to calendar year 2014.
