

### RESOLUTION ACKNOWLEDGING THE HONORABLE CONGRESSWOMAN BARBARA LEE FOR HER YEARS OF DEDICATED LEADERSHIP IN THE FIGHT AGAINST HIV/AIDS

**WHEREAS**, Congresswoman Barbara Lee has fought on behalf of the 40 million people around the world living with the HIV/AIDS disease both locally and globally; and

**WHEREAS**, Congresswoman Lee's steadfastness and undaunting vision has lead to effective, bipartisan measures to help prevent the spread of HIV/AIDS; and

**WHEREAS**, Congresswoman Lee successfully passed meaningful legislation that will initiate multilateral international efforts to fight HIV/AIDS; and

**WHEREAS**, Congresswoman Lee authored the original legislation to remove the travel and immigration ban for persons with HIV/AIDS in 2007 and played a key role in President Barack Obama's decision to formally repeal the United States travel and immigration restrictions on people living with HIV/AIDS on October 30, 2009; and

**WHEREAS**, the HIV/AIDS travel ban did not protect public health and furthered the stigma and discrimination associated with the disease; and

**WHEREAS**, the lifting of the HIV/AIDS travel ban will enable the United States to increase its participation in and host vitally important HIV/AIDS work, research, and conferences which previously could not take place due to the travel ban; and

**WHEREAS**, lifting the HIV/AIDS travel ban is consistent with the United States position as an international leader; and

**WHEREAS**, the City of Oakland applauds Congresswoman Lee for her leadership and compassion in leading these human rights efforts; and

**WHEREAS**, we salute Congresswoman Lee for her commitment to improving the quality of life for residents of the City of Oakland and the 9<sup>th</sup> Congressional District; now therefore be it

**RESOLVED:** that the elected officials, staff and citizens of Oakland are honored to recognize Congresswoman Barbara Lee for her outstanding service and contributions to the fight against HIV/AIDS; and be it

**FURTHER RESOLVED:** That a copy of this resolution, suitably inscribed, be presented to Congresswoman Lee with the compliments of the Mayor; the City Council and the City Administrator as a token of their appreciation and highest esteem.
