RESOLUTION NO. 89417 C.M.S.

RESOLUTION AMENDING RESOLUTION NO. 86915 C.M.S. AND RESOLUTION NO. 87623 C.M.S. TO AUTHORIZE THE CITY ADMINISTRATOR TO APPLY FOR, ACCEPT, AND APPROPRIATE FUNDS FROM CALIFORNIA DEPARTMENT OF RESOURCES RECYCLING AND RECOVERY COMPETITIVE AND NON-COMPETITIVE GRANTS BEGINNING WITH FISCAL YEAR 2022/2023 AND EFFECTIVE FOR FIVE (5) YEARS

WHEREAS, Public Resources Code sections 48000 et seq. authorize the State of California (State) Department of Resources Recycling and Recovery (CalRecycle) to administer various competitive and non-competitive grants in furtherance of the State's efforts to reduce, recycle, and reuse solid waste generated in the state thereby preserving landfill capacity and protecting public health and safety and the environment; and

WHEREAS, in furtherance of this authority, CalRecycle is required to establish procedures governing the application, awarding, and management of the grants; and

WHEREAS, CalRecycle requires, among other things, an applicant's governing body to declare by resolution certain authorizations related to the administration of CalRecycle grants; and

WHEREAS, Council Resolution No. 86915 C.M.S. authorizes the City Administrator to apply for any competitive CalRecycle grant for which the City is eligible without authorizing the City Administrator to accept and appropriate funds so awarded; and

WHEREAS, Council Resolution No. 87623 C.M.S. authorizes the City Administrator to apply for all CalRecycle grants for which the City is eligible and to execute all grant documents, without authorizing the City Administrator to accept and appropriate funds so awarded; now, therefore, be it

RESOLVED: That Resolution No. 86915 C.M.S. and Resolution No. 87623 C.M.S. are hereby amended to authorize the City Administrator to submit application(s) to CalRecycle for all grants for which the City is eligible, and to accept, and appropriate funds so awarded to the California Integrated Waste Management Board Fund (2154), Environmental Services: Recycling Solid Waste Organization (30682), Recycling and Solid Waste Program (SC17), in a Project Account to be determined; and be it

FURTHER RESOLVED: That the City Administrator is hereby authorized and empowered to execute in the name of the City all grant documents, including but not limited to, applications, agreements, amendments, annual reports including expenditure reports, and any subsequent amendments to or extensions of said documents and requests for payment, necessary to secure grant funds and implement the approved grant project; and be it

FURTHER RESOLVED: That this authorization is effective beginning with fiscal year 2022/2023 and for five (5) years; and be it

FURTHER RESOLVED: That the City Attorney's Office has reviewed this resolution for form and legality and a copy of this resolution shall be filed with the City Clerk.


