ORDINANCE AMENDING OAKLAND MUNICIPAL CODE SECTION 10.48.010 "PARKING FINES" TO INCREASE THE FINES FOR VIOLATIONS OF OAKLAND TRAFFIC CODE SECTIONS 10.40.020A1 "NO PARKING IN A RED ZONE"; 10.44.120A "RESIDENTIAL PERMIT PARKING ZONE", AND TO MODIFY THE CODE AND DESCRIPTION OF THE OAKLAND TRAFFIC CODE SECTION 10.40.020B "NO PARKING - RED ZONE, GREEN ZONE"

WHEREAS, the City of Oakland wishes to preserve the livability, social, and economic stability of the City; and

WHEREAS, the City of Oakland has a duty to enforce parking violations as set forth by the Oakland Municipal Code; and

WHEREAS, the City of Oakland collects revenues used to support a multitude of public services from fines resulting from parking violations; and

WHEREAS, the City of Oakland is considering a number of spending reduction proposals and revenue enhancements as a means to eliminate a projected budget deficit for the current fiscal year and beyond; now therefore

THE COUNCIL OF THE CITY OF OAKLAND DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1. The Municipal Code is hereby amended to add, delete, or modify sections as set forth below, additions are indicated by underscoring and deletions are indicated by ~~strike-through type~~; portions of the regulations not cited or not shown in underscoring or strike-through type are not changed.


SECTION 2. Section 10.48.010 of the Municipal Code is hereby amended to read as follows:

This Ordinance will amend Oakland Municipal Code Chapter 10.48.010 “Parking Fines” to increase the fines for Section 10.40.020A1 “No Parking in a red zone”; 10.44.120A “Residential Permit Parking Zone”, and to modify the code and description of the Oakland Traffic Code Section 10.40.020B to read as:
