RESOLUTION AMENDING RESOLUTION NO. 85125 C.M.S. WHICH AUTHORIZED A GRANT OF \$500.00 FROM COUNCILMEMBER KAPLAN'S PAY-GO FUNDS TO GOOD HOPE BAPTIST CHURCH'S YOUTH GROUP FOR TRAVEL AND MEAL EXPENSES TO DISNEYLAND, CA, TO CHANGE THE GRANTEE NAME TO GALATIANS BAPTIST CHURCH

WHEREAS, on July 17, 2007, the City Council revised the Pay-Go procedures to require City Council approval for any pay-go expenditures for purposes other than City or other governmental infrastructure, furniture, or equipment expenditures; and

WHEREAS, on July 29, 2014 the City Council approved Resolution No. 85125 C.M.S. authorizing a grant of \$500.00 from Councilmember Rebecca Kaplan's Pay-Go funds to the Good Hope Baptist Church's Youth Group for travel and meal expenses to Disneyland, CA; and

WHEREAS, an amendment to resolution No. 85125 C.M.S. is needed to change the name of the grantee from Good Hope Baptist Church to Galatians Baptist Church; and

WHEREAS, in conformance with City requirements, the Galatians Baptist Church's Youth Group will provide documentation for the use of the Councilmember's Pay-Go funds; now, therefore, be it

RESOLVED, that the City Council hereby amends Resolution No. 85125 C.M.S. which authorized a grant of \$500.00 from Councilmember Rebecca Kaplan's Pay-Go funds to the Good Hope Baptist Church's Youth Group for travel to Disneyland, CA to change the name of the grantee to Galatians Baptist Church; and, be it

FURTHER RESOLVED, that the City Administrator is authorized to execute a grant agreement with the Galatians Baptist Church's Youth Group in the amount of \$500.00 for the above purpose, subject to approval as to form and legality by the City Attorney.
