This ordinance authorizes changes to the City's Classification Plan as shown in the City's Salary Schedule to add new classifications and amend existing classification titles and salary rates. Various departments are requesting new classifications to align with operational and service delivery needs. This applies to the: Inspector General Program & Performance Audit Manager, Inspector General Program & Performance Auditor, and Inspector General Policy Analyst in the Office of the Inspector General; Family Services Specialist in the Human Services Department; Special Activity Permit Technician in the Economic and Workforce Development Department; and the permanent part-time and part-time equivalent classifications of Community Intervention Specialist (MACRO) and Emergency Medical Technician (MACRO) in the Oakland Fire Department. Several job titles are being adjusted to better reflect titling trends in the market. This applies to the former job titles of: Environmental Services Analyst, Assistant; Recycling Specialist; Municipal Code Enforcement Officer; and Head Start/Early Head Start Substitute Instructor. The pay rates for the Senior Aide, PT and Temporary Contract Services Employee, PT classifications are being raised to align with the City of Oakland's new minimum wage rate that took effect January 1, 2022 per requirements in Measure FF and the Oakland Municipal Code Section 5.92. Lastly, the pay rate for the Council Member classification is being increased to reflect the Oakland Public Ethic Commission's mandated salary increase in alignment with Section 202 of the Oakland City Charter and as authorized by Resolution No. 22-02 of the Oakland Public Ethic Commission
