WHEREAS, during her 20 years as Center Director at Studio One Art Center she developed and refined an exciting program of art classes and workshop in a myriad of disciplines including painting, drawing, jewelry, glass, photography and ceramics; and

WHEREAS, under Ms. Morton's leadership, thousands of Oakland citizens of all ages have walked through the doors of Studio One and found a warm, supportive atmosphere in which to explore and expand their creativity and skills; and

WHEREAS, Johnette J. Morton has decided to begin her retirement so she can spend more time with her family, complete her ministerial education, and continue to bring her unique creative energy to all her future endeavors; now, therefore be it

RESOLVED: That the Mayor and members of the Oakland City Council, the Parks and Recreation Advisory Commission, the City Administrator, the Director and the staff of the Office of Parks and Recreation commend Ms. Johnette J.
