In these challenging economic and political times, arts and culture remain critical for healing, defining, imagining, creating, and strengthening the City of Oakland and our diverse communities. My myriad of experiences and qualifications make me uniquely qualified to participate as part of the Cultural Affairs Commission, and I am excited at the prospect of being able to contribute to the ongoing arts and culture work in Oakland. I have been involved with the arts and culture for most of my 49 years as an artist, culture creator, culture keeper, advocate, educator, educationalist, mentor, researcher, and business owner. I am most publicly known as a GRAMMY-nominated hip hop artist named Mystic, who explores and centers healing, community, social justice, and the power and beauty of our local and global communities within my music. I was recently inducted into the Bay Area Hip Hop Archives and also honored with a proclamation by Mayor Sheng Thao as one of a group of women artists who have contributed to hip hop culture in Oakland and beyond. Having released an album that year, I remain an active artist and run my own record label here in Oakland. Additionally, I am a Governor on the San Francisco Chapter Recording Academy Board and served last year as a co-chair of the Advocacy Committee. I also sit on the board of Diversify The Stage, which works nationally to diversify who works behind the lights in the music industry. As an educator, educationalist, mentor, advocate, and published researcher on equity in education in connection with policymaking and a researcher on the use of culturally relevant arts education. I am deeply interested in access to the arts and arts education, public art, who and what is recognized and valorized within the creation of culture and arts policy, and the power of arts and culture in connection with social justice and democracy. I have developed and implemented arts curricula and deeply researched policy concerning the arts. I am currently part of the continuing Arts and Humanities Justice Coalition that worked with Congresswoman Barbara Lee's office to craft the Advancing Equity Through the Arts and Humanities Act to address systemic racism through arts and increase equity in funding for organizations and individuals who do this critical work through the arts. This policy work opened up powerful opportunities to advocate for arts and culture funding and artists' rights with Californians for The Arts and the Recording Academy on state and federal levels. I understand Oakland has competing demands in various areas throughout the budget. I also appreciate how complex it can be to navigate various stakeholders. Having the opportunity to use the plethora of knowledge and experiences I have, I can add a valuable voice to the Cultural Affairs Commission to educate and advise local government and the community on affairs pertaining to our city's arts and culture. I am also open to learning what I do not know and working with existing members of the Commission for the most significant benefit of our communities. My love of community and my strengths in research, collective work, advocacy, and a deep understanding of policymaking and public policy will allow me to make valuable additions to the already great work that has been happening. As a Black woman whose life has been guided by and saved by being a participant in the arts and creating culture, I am an emphatic believer that funding and public opportunities for artists and the creation of public and community arts and culture should be available to the most economically vulnerable communities and the most underserved populations and identities. I celebrate the Commission's work, and it would be my honor to be selected for one of the available spaces. I advocate for serving others, and I would love to have the opportunity to serve in this advisory capacity for and with the people of Oakland. Even with the challenges, we are in an exciting time in Oakland in terms of creating a sustainable future and seeking and reimaging new solutions. We can rise to our collective challenges while supporting a thriving arts and culture scene in our city—it is critical to who we are and want to be.

# RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENTS OF CANDI MARTINEZ, MANDOLYN LUDLUM, AND OLAYWA AUSTIN TO THE CULTURAL AFFAIRS COMMISSION

**WHEREAS,** Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

**WHEREAS,** Ordinance No. 11323 C.M.S., amended by Ordinance Nos. 11778 C.M.S. and 13561 C.M.S., establishes the Cultural Affairs Commission as a professionally qualified citizen committee responsible for advising the City regarding all matters affecting arts and cultural development in the City of Oakland; and

**WHEREAS,** Ordinance No. 13561 C.M.S. provides that all terms shall commence on October 1 and end on September 30, and for the initial appointment only, four members shall be appointed for a three-year term, four members shall be appointed for a two-year term, and three members shall be appointed for a one-year term, and thereafter, all appointments shall be for three years; and

**WHEREAS,** Ordinance No. 13561 C.M.S. provides that no person shall be appointed to serve as a member of the Cultural Affairs Commission for more than two consecutive three-year terms plus any initial term of less than two years; and

**WHEREAS,** the Honorable Mayor Sheng Thao has appointed Candi Martinez, Mandolyn Ludlum, and Olaywa Austin to serve on the Cultural Affairs Commission; now, therefore, be it

**RESOLVED:** That pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointments of:

**Candi Martinez**, to serve a three-year term on the Cultural Affairs Commission beginning October 1, 2023 and ending September 30, 2026, filling the seat previously held by Shannon Price.
