RESOLUTION AUTHORIZING A WAIVER OF THE LOCAL AND SMALL LOCAL BUSINESS ENTERPRISE PROGRAM PROVISIONS RELATIVE TO A PROFESSIONAL SERVICES AGREEMENT WITH CROSS-SECTOR SOLUTIONS, LLC, PREVIOUSLY APPROVED BY RESOLUTION 79275 C.M.S., FOR CONSULTING AND TECHNICAL **SERVICES** WITH THE POLICE **DEPARTMENT'S** ENFORCEMENT RESPONSE TO HUMAN TRAFFICKING GRANT PROGRAM AND THE EAST BAY TASK FORCE ON HUMAN TRAFFICKING

WHEREAS, the United States Department of Justice (USDOJ), Office of Justice Programs. Office for Victims of Crime, awarded the Police Department a Law Enforcement Response to Human Trafficking grant in the amount of \$450,000 for the period December 1, 2004 through November 30, 2007; and

WHEREAS, the City Council accepted of the grant funds and execution of the contract for services with Cross-Sector Solutions, LLC by Resolution No. 79275 C.M.S. dated June 7, 2005; and

WHEREAS, the vendor identified in the original resolution, Cross-Sector Solutions, LLC, does not meet the City of Oakland's twenty percent (20%) minimum participation requirement for professional services contracts of \$50,000 or more associated with Local and Small Local business Enterprise Programs; and

WHEREAS, the Police Department still desires to enter into a three-year, Professional Services Agreement with Cross-Sector Solutions, LLC in an amount not to exceed \$119,500 for consulting and technical services to the Oakland Police Department and the East Bay Task Force on Human Trafficking, to be funded by the grant; and

WHEREAS, the City Council finds that the services provided pursuant to the agreement with Cross-Sector Solutions, LLC authorized hereunder are of a professional, scientific or technical nature and are temporary in nature; and

WHEREAS, the City Council finds the agreement with Cross-Sector Solutions, LLC shall not result in a loss of employment or salary by any person having permanent status in the competitive service; now, therefore be it

RESOLVED: That the City Council hereby authorizes a waiver of the Local and Small Local Business Enterprise Program Provision in relationship to a Professional Services Agreement with Cross-Sector Solutions, LLC for the Police Department's Law Enforcement Response to Human Trafficking grant program; and be it

FURTHER RESOLVED: That the City Administrator or her designee is further authorized to execute all agreements and other documents necessary in connection with the contract and complete any negotiations, certifications and documentation required to accept, modify, extend, or amend the agreement provided no additional funds will be allocated without prior Council approval.

FURTHER RESOLVED: That the City Attorney shall review and approve said agreement with Cross-Sector Solutions, LLC and a copy of the fully executed agreement shall be placed on file with the Office of the City Clerk.
