





RESOLUTION CONFIRMING THE MAYOR'S REAPPOINTMENT OF PATRICIA CARINO VALDEZ AND APPOINTMENT OF JENNIFER CORREIRA, ERIC MURPHY, AND MICHELE RAMIREZ TO THE PUBLIC ART ADVISORY COMMITTEE

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

**WHEREAS**, Ordinance No. 11086 C.M.S. creates the Public Art Advisory Committee as a professionally qualified citizen committee responsible for advising the City regarding its public art program, and provides that the Public Art Advisory Committee has nine members; and

**WHEREAS**, the Public Art Advisory Committee has approved bylaws providing that members shall serve three-year terms with no more than two consecutive terms; and

WHEREAS, the Honorable Mayor Libby Schaaf has reappointed Patricia Carino Valdez and appointed Jennifer Correira, Eric Murphy, and Michele Ramirez to serve a three (3) year term on the Public Art Advisory Committee subject to confirmation of the City Council; now, therefore, be it

**RESOLVED:** That the City Council hereby confirms the Mayor's reappointment of:

**Patricia Carino Valdez**, to serve a three-year term on the Public Art Advisory Committee beginning October 1, 2018 and ending September 30, 2021, filling a seat previously held by herself; and be it

**FURTHER RESOLVED**: That the City Council hereby confirms the Mayor's appointment of:

**Jennifer Correira,** to serve a three-year term on the Public Art Advisory Committee beginning February 1, 2018 and ending January 31, 2021, filling a seat previously held by Allison Cummings.

**Eric Murphy,** to serve a three-year term on the Public Art Advisory Committee beginning October 1, 2018 and ending September 30, 2021, filling a seat previously held by Joyce Gordon.

**Michele Ramirez,** to serve a three-year term on the Public Art Advisory Committee beginning November 17, 2018 and ending November 16, 2021, filling a seat previously held by Evelyn Orantes.
