AS MEMBERS OF THE YOUTH ADVISORY COMMISSION

Nseke Ngilbus, as Commissioner, is appointed to serve the term November 3, 2006 to November 2, 2008 fulfilling the unexpired term previously held by Christina Jiang.

Ailish F. Elzy, as Commissioner, is appointed to serve the term November 2, 2006 to November 1, 2008 fulfilling the unexpired term previously held by Amber Arnold.

Kenitra Holland, as Commissioner, is appointed to serve the term November 3, 2006 to November 2, 2008 filling the seat previously held by Patrick Sean Weston.

Vanessa Monique Nutters, as Commissioner, is appointed to serve the term July 1, 2007 to June 30, 2009 filling the seat previously held by Branden Williams and then vacant.

ShaCora Cowart, as Commissioner, is appointed to serve the term July 1, 2007 to June 30, 2009 filling the seat previously held by Samantha Taylor and then vacant.


