**RESOLUTION AUTHORIZING COUNCILMEMBER DESLEY BROOKS TO TRAVEL TO SEATTLE, WASHINGTON TO ATTEND THE 2013 NATIONAL LEAGUE OF CITIES' CONGRESS OF CITIES AND EXPOSITION ANNUAL CONFERENCE FROM NOVEMBER 13, 2013 – NOVEMBER 16, 2013**

**WHEREAS**, Council Member Desley Brooks, wishes to attend the 2013 National League of Cities Congress of Cities and Exposition Annual Conference in Seattle, Washington from November 13, 2013 to November 16, 2013; and

**WHEREAS**, pursuant to City Council Resolution No. 82800 C.M.S. approved by Council on June 1, 2010, which establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging, and shall provide an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used and the source of City and/or Redevelopment Agency funding that will be used to cover the travel costs; and

**WHEREAS**, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost of transportation (including airfare and taxis) is \$500.00, of lodging is \$1,200.00 for four nights, of per diem is \$224.00 for four days, and of conference registration fees is \$560.00, and

**WHEREAS**, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from City Council District 6 funds; and

**WHEREAS**, Council Member Desley Brooks seeks Council approval of the aforementioned estimated costs to travel to Seattle, Washington to attend the 2013 National League of Cities Congress of Cities and Exposition Annual Conference, November 13, 2013 to November 16, 2013; now, therefore, be it

**RESOLVED**: that all expenses incurred for said travel are hereby authorized.
