#### **SUMMARY**

Staff requests approval of resolutions authorizing the City Administrator to execute Grant, Professional Services and Rental Agreements with six early care and education service providers for Early Head Start Comprehensive Early Care and Education services during the program year: 2009-10: Brighter Beginnings In A 2009-10 Ten-Month Amount Not To Exceed \$597,807 And a 2010-11 Twelve-Month Amount Not To Exceed \$670,548; YMCA In A 2009-10 Ten-Month Amount Not To Exceed \$193,000; And a 2010-11 Twelve-Month Amount Not To Exceed \$156,000; Children's Hospital - Oakland In A 2009-10 Ten-Month Amount Not To Exceed \$88,500 And a 2010-11 Twelve-Month Amount Not To Exceed \$68,400; and Teresita Gordon, Early Childhood Nutrition Consultant In A 2009-10 Ten-Month Amount Not To Exceed \$37,500 And a 2010-11 Twelve-Month Amount Not To Exceed \$50,000; Oakland Ready To Learn and Lotus Bloom Child and Family Resource Center In A 2009-10 Ten-Month Amount Of \$5,976 Each Not To Exceed \$11,952 And a 2010-11 Twelve-Month Amount Of \$7,200 Each Not To Exceed \$14,400; For An Aggregate 2009-10 Amount Not To Exceed \$928,759 For Early Head Start Comprehensive Early Care and Education Services, And Contingent Upon Receipt Of Grant Funding, To Extend Grant Funding Of Each Grant, Professional Services and Rental Agreement For One Additional Year; 2010-11, In An Aggregate Amount Not To Exceed \$959,348, For A Two-Year Total Not To Exceed \$1,888,107.

If approved, funding will support the comprehensive service delivery of quality Early Head Start early care and education services, in home-based and center-based settings, full-day, full-year, beginning January 1, 2010. Services will include onsite early childhood mental health assessment and consultation for families with children, birth – 3, along with early childhood mental health training for Early Head Start Infant/Toddler teachers and program staff. Services will also include mandatory nutrition assessment, planning, education and training for families with children, birth-3, along with nutrition education and training for Infant/Toddler teachers and program staff.

The Oakland Early Head Start Program will, directly and through contract agreements and MOU's with strategic community partners, provide Early Head Start services to approximately 204 families, including pregnant women, infants and toddlers, in Oakland, during the program year that begins September 1, 2009 through August 31, 2011. Strategic community partners, Brighter Beginnings and YMCA, combined will serve a total of 124 income eligible families,

Item: \_\_\_\_\_\_ Life Enrichment Committee December 1, 2009 with children, birth-3 (Brighter Beginnings will provide home-based Early Head Start services to 84 families and the YMCA will provide center-based Early Head Start services to 40 families).

Through the Grantee's center-based service model, which will serve 32 families, with children birth – 3, Children's Hospital – Oakland, Early Intervention Services will provide onsite early childhood mental health assessment and consultation for participating families and children, along with Early Head Start Infant/Toddler teachers and program staff. The Grantee's center-based services will be located at First African Methodist Episcopal Church (FAME), located at 3701 Telegraph Avenue and First Presbyterian Church, located at 2619 Broadway in Oakland. Through the Grantee's home-based service model, which will serve 48 families with children, birth – 3, socialization activities will occur two times per month at developmentally appropriate socialization locations, Oakland Ready to Learn, 436 14<sup>th</sup> Street, Suite 815; and Lotus Bloom Child and Family Resource Center, located at 2008 Park Blvd.

#### FISCAL IMPACT

Contingent upon receipt of grant funding, funding will be available for the Grant, Professional Services and Rental Agreements in the Early Head Start program budget, Department of Health and Human Services ARRA Fund (2605), Head Start Organization (78231), Early Head Start Project (project number to be determined). Funding for these Grant, Professional Services and Rental Agreements is anticipated from the 2009-10 ARRA Early Head Start Grant Application, approved by City Council on July 7, 2009 Resolution No. 82130 C.M.S.

#### **BACKGROUND**

On May 8, 2009, under the American Recovery and Reinvestment Act (ARRA), the US Department of Health & Human Services, Administration for Children and Families released a Request for Application (RFA), making Early Head Start program expansion opportunities available, to local public and local non-profit and for-profit private entities, including Early Head Start and Head Start grantees. The funding opportunities, in the amount of \$619 million, will be competitively awarded for the purpose of expanding enrollment by approximately 55,000 low-income children and their families, nationwide. The expansion is only to increase the number of pregnant women, infants and toddlers served in Early Head Start. Successful applicants will be subject to reporting requirements consistent with the Act and with current Head Start regulations. All applications are encouraged to develop strategic and collaborative community partnerships with highly qualified early care and education services providers, in order to further maximize the comprehensive benefits of Early Head Start programming, provided for families with children, birth-3, who are most in need.

Established in 1995, Early Head Start is a program for low-income families with infants and toddlers and pregnant women. Evidence from research and practice, indicates that the time from conception to age three is critical for human development and that for infants and toddlers to develop optimally, they must have healthy beginnings and the continuity of responsive, caring

Early Head Start programs provide family-centered services, with home-based and center-based options, designed to promote the development of the youngest children, and enable their parents to fulfill their roles as parents, while moving toward self-sufficiency.

The City of Oakland has been a grantee for the Head Start Program since January 1972. Head Start is a national early childhood education program that promotes school readiness by enhancing the social and cognitive development of preschool children through the provision of educational, health, nutritional, social and other services to economically disadvantaged children and families.

In 1988, the City entered into a grantee-delegate relationship with the Unity Council to serve children and families in the Fruitvale District. The Unity Council is located in a service area with high need, and has the capacity to provide childcare for over 500 children, of these 200 is served by the Early Head Start program.

The Unity Council Early Head Start program currently operates three Early Head Start (EHS) programs in East, Central (Fruitvale District) and West Oakland.

#### KEY ISSUES AND IMPACTS

Early Head Start services for families with children, birth-3, are currently being provided in East, Central and West Oakland, as indicated above. However, responses from the Oakland Head Start's 2009 Parent Needs Survey and Community Assessment Update, along with Alameda County Public Health Department, CAPE Unit's (ACPHD) 2007 Medi-Cal birth data, indicate a substantial unmet need for services for children birth -3, and their families, in Oakland.

#### PROGRAM DESCRIPTION

The Oakland Early Head Start Program will, directly and through contract agreements and MOU's with strategic community partners, provide Early Head Start services to approximately 204 families, including pregnant women, infants and toddlers, in Oakland, during the program year that begins September 1, 2009 through August 31, 2011.

A collaborative service delivery model for the Oakland Early Head Start program has been established, which will include approximately 204 slots for families with infants (birth – 18 months) and toddlers (18-36 months).

In order to expand the reach of Early Head Start services for income eligible families, with children, birth- 3, throughout Oakland, Oakland Head Start proposes to offer the following program options, which include Grantee-operated and Grantee/Partner-operated configurations:

➤ Home-Based: Similar to Head Start home-based services, in-home Early Head Start services will be provided for families by an Early Head Start Home Visitor; 1x/week; 1.5-2 hours/session. The Home-Based option also provides a center-based, group oriented Socialization session for infants and toddlers and their families, approximately twice a month; 3 hours/session. The Socialization session provides an opportunity for infants and toddlers and their families, to interact socially and gradually develop their social-emotional skills in a center-based, group setting. The Home-Based option is available for mothers who have had a baby and/or who have young toddlers, and would prefer in-home early care and education services to support their children's growth and development.

The Grantee and Early Head Start Home-Based Partner, Brighter Beginnings, will provide quality home-based services and developmentally appropriate socialization settings for 132 income eligible families with children, birth – 3, Monday – Friday, full-day, full-year.

Early Head Start Home-Based Socialization Partners, Oakland Ready to Learn and Lotus Bloom Child and Family Resource Center, will provide developmentally appropriate socialization settings, 2 times per month, for 3.5 hours, per session, Monday-Friday.

➤ Center-Based: Similar to Head Start center-based services, Early Head Start center-based services will be provided for families by highly qualified Early Childhood Educators, with specific training and experience working with children, birth – 3. Services will be comprehensive. Early Childhood Mental Health assessment, consultation and training will be provided for participating Early Head Start family and staff, by Children's Hospital – Oakland, Early Intervention Services. High quality nutrition assessment, education, menu planning, and training will also be integrated into the service delivery model. A highly qualified Nutrition Consultant, Teresita Gordon, will provide comprehensive nutrition services for participating Early Head Start families and staff.

The Grantee and Early Head Start Partner, YMCA, will provide quality center-based services to 72 income eligible families with children, birth-3, Monday – Friday, full-day, full year.

#### SUSTAINABLE OPPORTUNITIES

#### Economic:

The expected economic benefits to the City from the operation of the Early Head Start Program include the creating of jobs, including people directly employed in centers, plus an unknown number of jobs through its economic multiplier effect.

It is expected that most of these jobs are held by residents of Oakland. In addition, Early Head Start will buy goods and services to support its program, and most of these will be purchased from Oakland firms or individuals.

#### Environmental:

It is expected that there will be no direct environmental benefits or impacts from the Early Head Start program to the City of Oakland. Similar to the Oakland Head Start program, the program will use recyclable paper products.

#### Social Equity:

Similar to the Oakland Head Start program, the principal sustainable opportunity of the Early Head Start Program will be in the area of social equity. The Oakland Early Head Start Program will deliver comprehensive, high-quality services to children and families in the City of Oakland.

#### DISABILITY AND SENIOR CITIZEN ACCESS

All existing and future Oakland Early Head Start centers are in compliance with the Americans with Disabilities Act (ADA) and the Older Americans Act.

WHEREAS, the Department of Human Services, Oakland Head Start program has found Brighter Beginnings home-based programming for low-income pregnant and parenting teens of children, birth-3, to be a highly qualified, highly needed and cost effective means of providing families with quality Early Head Start services and full-day, full-year child care; and

WHEREAS, the Oakland Head Start program has received authorization from the U.S. Department of Health and Human Services to provide Early Head Start services for up to 204 income eligible families, with children, birth-3, 84 of whom will be served by Brighter Beginnings; and
