RESOLUTION AUTHORIZING SUBMITTAL OF GRANT APPLICATIONS AS LEAD JURISDICTION TO THE CALIFORNIA INTEGRATED WASTE MANAGEMENT BOARD, AND APPROPRIATION OF THOSE GRANT FUNDS, FOR USED MOTOR OIL AND USED OIL FILTER RECYCLING FOR FIVE YEARS.

WHEREAS, the people of the State of California have enacted the California Oil Recycling Enhancement Act that provides for Used Oil Recycling Block Grants (grants) to eligible cities and counties for establishing and maintaining local used oil collection programs that encourage recycling or appropriate disposal of used oil; and

WHEREAS, the California Integrated Waste Management Board (CIWMB) has been delegated the responsibility for administering the grants, which includes procedures governing the application by and payment to eligible cities and counties; and

WHEREAS, if awarded the City of Oakland (City) will enter into an agreement with the CIWMB for the development of the projects as specified in the grant applications; and

WHEREAS, procedures established by the CIWMB require the grant applicant to certify by resolution the approval of said applications; and

WHEREAS, the City will submit grant applications for Used Oil Recycling Block Grants for used motor oil and oil filter collection and recycling services and public education activities; and

WHEREAS, all jurisdictions in Alameda County are member agencies of the Alameda County Waste Management Authority (ACWMA), a regional Joint Powers Authority (JPA) that was formed for the purpose of, and having expertise in, recycling and solid waste project planning and implementation; and

WHEREAS, ACWMA is empowered to make and enter into contracts with its member agencies, including either to receive or provide services; and

WHEREAS, the City and other Alameda County jurisdictions have agreed, but are not committed, to provide a percentage of used oil block grant funds to the ACMWA to provide regional used oil and oil filter recycling public education; and

WHEREAS, the City desires to have the ability to join with participating jurisdictions in the implementation of a regional used oil public education program, now; and

WHEREAS, Oil Grants will allow the City to further the goals of recycling and waste reduction and meet the Mayor's and City Council's goals of Developing a Sustainable City and Improving Oakland's Neighborhoods, now, therefore be it

RESOLVED: That the City Council hereby authorizes the submittal of applications to the CIWMB for Used Oil Block Grants over the next five years; and be it

FURTHER RESOLVED: That the City Manager or a designee is hereby authorized and empowered to execute in the name of the City of Oakland any and all documents currently required by the CIWMB, and any subsequent amendments to or extensions of said documents, to secure grant funds and implement approved grant projects; and be it

FURTHER RESOLVED: That the City Manager or a designee is hereby authorized to receive and appropriate the funds to the California Integrated Waste Management Fund 2154, to expend the funds on used motor oil and oil filter collection and public education activities; and be it

FURTHER RESOLVED: That, should the ACWMA, other Alameda County jurisdictions and the City agree to implement Countywide public education campaign, the City Council authorizes the expenditure of appropriated grant proceeds to be payable to ACWMA for that purpose; and be it

FURTHER RESOLVED: That the City Council authorizes the City of Oakland to be applicant and lead jurisdiction for Used Oil Recycling Block Grants on behalf of itself, and participating jurisdictions that authorize the City to act on their behalf; and be it

FURTHER RESOLVED: That the City Attorney's Office has reviewed this resolution as to form and legality and a copy of this resolution shall be filed with the City Clerk.
