A RESOLUTION AMENDING RESOLUTION NO. 75410 C.M.S. TO AUTHORIZE A MODIFICATION OF THE MEMORANDUM OF UNDERSTANDING WITH THE PORT OF OAKLAND AND THE REDEVELOPMENT AGENCY FOR THE HEGENBERGER GATEWAY PROJECT TO ACKNOWLEDGE INCREASED CITY FUNDING OF THE PROJECT BY AN ADDITIONAL \$235,000

WHEREAS, the Cities of San Leandro and Oakland (“Cities”) have completed and adopted a Joint Revitalization Plan under the Association of Bay Area Governments’ (“ABAG) Comprehensive Sub-regional Planning Project for the border area shared by the Cities; and

WHEREAS, the Port and the Alameda County Transportation Agency (“ACTA”) as well as the Cities are involved in implementing projects in the western portion of the Joint Revitalization Plan area more particularly described as the Airport Gateway Area; and

WHEREAS, the Cities and the Port have adopted an Urban Design Concept for the Airport Gateway Area which incorporates proposed improvements for Hegenberger Road between Doolittle Drive and 1-880 (the “Project”); and

WHEREAS, Resolution No. **75410** C.M.S. authorized the City to enter into a Memorandum of Understanding (“MOU) for the purpose of funding and facilitating implementation of the Project with the Redevelopment Agency and the Port of Oakland, which MOU provided for \$1,850,000 in Agency funding and \$115,000 in City ISTEA grant funding for the Project; and

WHEREAS, the Agency desires to increase the amount of Agency funding to the Project by \$1,000,000, including additional contingency, to bring the total Agency contribution to the Project to \$2,850,000, contingent on a match in this amount from the Port; and

WHEREAS, the City through Resolution No. 75984 C.M.S. has authorized \$350,000 in ISTEA grant funding for the Project; and

WHEREAS, the City wishes to modify the MOU to acknowledge the increase of the \$235,000 in City ISTEA grant funding to a total of \$350,000; now, therefore, be it

RESOLVED: That Council Resolution No. 75410 C.M.S. is hereby amended to provide that the City Manager or his designee is authorized to execute the MOU with the Port of Oakland and the Redevelopment Agency for the Project to provide for City ISTEA grant funding in the amount of \$350,000.


