A RESOLUTION RECOGNIZING AND HONORING DIRECTOR OF FINANCE KATANO KASAINE FOR RECEIVING THE 2018 FREDA JOHNSON AWARD FOR TRAILBLAZING WOMEN IN PUBLIC FINANCE

WHEREAS, Katano Kasaine, Director of Finance/Treasurer, City of Oakland, has over two decades of local government experience and manages all aspects of the City's finance functions, including City and Oakland Redevelopment Successor Agency debt financings, budgets, revenue collection/administration, and Controller functions and City, ORSA, and Port of Oakland cash and investment portfolios, as well as, serves on various boards; and

WHEREAS, Katano Kasaine, throughout her nearly 25-year career with the City, has established a reputation for building peak-performing teams and aligning financial and business strategy to support efficiency, productivity and high-growth helping to transform the City and effectively serve constituents thanks to her strategic thinking, results-driven leadership, passion for civic engagement, and commitment to the City allowing her to provide sound investment decisions, develop prudent budget balancing measures during the economic downturn, and lead financings for multiple notable large-scale City projects and capital improvements as well as successfully raising, managing, and committing billions of City dollars to numerous projects, expanding the City's liquidity, and managing cost controls in numerous departments; and
