RESOLUTION CONGRATULATING BETA, THETA SIGMA CHAPTER OF THE SIGMA GAMMA RHO SORORITY ON THEIR 70TH ANNIVERSARY

Whereas, Sigma Gamma Rho Sorority, Inc. was founded on November 12, 1922 by seven educators at Butler University in Indianapolis, Indiana and has 85,000 members in 500 chapters in the U.S., Bahamas, Bermuda, the U.S. Virgin Islands, Canada, Germany and Korea; and

Whereas, Sigma Gamma Rho Sorority, Inc., Beta Theta Sigma Chapter was chartered on November 30, 1947 and was the first chapter of the organization established in Northern California; and

Whereas, Sigma Gamma Rho Sorority, Inc., Beta Theta Sigma Chapter was initially comprised of members from across the country who made California their home, most of whom were educators employed in the Oakland, Berkeley and San Francisco school systems – Evelyn Coleman Draper, Marie Spann Ivy, Gladys Boone, Ceola Coleman, Gertrude Barrett Davis Fox, Vallie Doyle, Gladys Boone, Ann King, Illistine Smith, Rebecca Brown and Vivian Vincent; and

Whereas, the mission of Sigma Gamma Rho Sorority, Inc., is to enhance the quality of life for women and their families in the U.S. and globally through community service, civil, and social action., Beta Theta Sigma chapter, based in Oakland, CA has provided programming in the areas of education, health awareness, and leadership development to the Greater Bay Area for seventy years; and

Whereas, Sigma Gamma Rho Sorority, Inc visualizes a world in which all women and their families reach their full potential in all aspects of life and creates unlimited opportunities for future generations which it accomplishes under the auspices of the national program, Project Reassurance, which focuses on Healthy Living, Healthy Choices, and Healthy Generations; and

Whereas, in alignment with vision of Sigma Gamma Rho Sorority, Inc., Beta Theta Sigma Chapter designs, develops and implements local initiatives and projects such as the Annual Youth Symposium, Hattie McDaniel Breast Cancer Awareness Workshop, Project Cradle Care, Operation Big Bookbag, Act Against AIDS in conjunction with the Center for Disease Control, Swim 1922, a program to increase the number of African American youth swimmers in conjunction with USA Swimming, Soles for Little Souls the annual holiday Adopt A Family program; and

Whereas, Sigma Gamma Rho Sorority, Inc., Beta Theta Sigma Chapter has been an integral part of the Oakland, providing hundreds of thousands of dollars in scholarships and greater service to community; now, therefore, be it

Resolved: that the City of Oakland hereby commemorates the 70th Anniversary of Sigma Gamma Rho Sorority, Inc., Beta Theta Sigma Chapter and extends gratitude for seven decades of service dedicated to the uplift of the educational, physical, civic and social wellbeing of all Oakland residents.


