**RESOLUTION DESIGNATING COUNCILMEMBER DAN KALB AS THE CITY OF OAKLAND'S VOTING DELEGATE AND COUNCIL PRESIDENT PATRICIA KERNIGHAN AS THE CITY OF OAKLAND'S ALTERNATE VOTING DELEGATE TO THE LEAGUE OF CALIFORNIA CITIES 2013 ANNUAL CONFERENCE SCHEDULED FOR SEPTEMBER 18-20 IN SACRAMENTO**

**WHEREAS**, the City of Oakland is a Member City of the League of California Cities; and

**WHEREAS**, the Bylaws of the League of California Cities, Article V, Section 3 (a) state: "Designation. Each Member City may, with the approval of the city council, designate a city official as the city's designated voting delegate and, in the event that the designated voting delegate is unable to serve in that capacity, up to two alternate voting delegates"; and

**WHEREAS**, the City Council's Rules of Procedure (Resolution No. 82580 C.M.S.) state that "the President of the Council shall recommend appointments to regional and local boards and agencies, as appropriate, subject to confirmation by the Council"; and

**WHEREAS**, Council President wishes to appoint Councilmember Dan Kalb as the City of Oakland's Voting Delegate to the League of California Cities' 2013 Annual Conference, and wishes to appoint Council President Patricia Kernighan as the City of Oakland's Alternate Voting Delegate to the League of California Cities' 2013 Annual Conference; now, therefore be it

**RESOLVED:** That Councilmember Dan Kalb is hereby appointed the City of Oakland's Voting Delegate for the League of California Cities' 2013 Annual Conference; and be it further

**RESOLVED:** That Council President Patricia Kernighan is hereby appointed the City of Oakland's Alternate Voting Delegate for the League of California Cities 2013 Annual Conference.
