**SUBJECT: PUBLIC HEARING ON ASSESSMENT OF LIENS FOR DELINQUENT  
BUSINESS TAXES**

---

**SUMMARY**

On August 24, 2005, staff held an administrative hearing for delinquent business taxes and attempted to resolve any inconsistencies or inequities prior to the public hearing before the City Council. The administrative and public hearings are held only after all other procedural means to resolve an unpaid business tax account have been exhausted.

**FISCAL IMPACT**

The liens will be recorded against 351 parcels owned by 307 property owners. The parcels' delinquencies represent \$468,711 in past due business taxes. Failure to place liens will result in a loss of \$486,261, including administrative processing fees, to the City's General Fund. This revenue was included in the FY2005-07 Policy Budget.

**BACKGROUND**

Staff cross-referenced the Alameda County Assessor data with the Business Tax System data to identify potential non-registrants owning various types of rental properties. Originally, the number of property owners notified of the City's business tax requirements for rental property operators was 420. The 420 non-responders were notified of the City's intent to record a lien against their property. The owners of 351 parcels/properties failed to resolve the delinquencies during the administrative hearing.


**RECOMMENDATION AND RATIONALE:**
