INTRODUCED BY COUNCIL MEMBER JEAN QUAN

RESOLUTION AUTHORIZING A GRANT FROM COUNCILMEMBER QUAN'S PAY-GO FUNDS TO CHABOT SPACE & SCIENCE CENTER IN THE AMOUNT OF ONE THOUSAND FOUR HUNDRED NINETY DOLLARS (\$1,490.00) TO FUND INSTALLATION OF THE CHABOT SPACE & SCIENCE CENTER HISTORIC MARKER IN LAFAYETTE SQUARE PARK.

WHEREAS, Chabot Space & Science Center has obtained three (3) bids for the Installation of the Historic Marker commemorating its 125th Anniversary, and has chosen one of the bidders Ergowiz to perform services of design, labor and permanent installation of a concrete pedestal for the Historic Marker at the original site of Chabot Observatory in Lafayette Square Park, and

WHEREAS, Councilmember Jean Quan wishes to reimburse this organization out of her pay-go fund account; and

WHEREAS, Chabot Space & Science Center is a unique educational asset to Oakland, with a focus on serving at-risk youth, a strong partnership with Oakland Unified School District, and service to Bay Area communities through school field trips, science camps and community outreach focusing on Earth, life, and physical sciences, benefiting 150,000 visitors and 50,000 students annually from the Center's world-class planetarium, interactive exhibits, and the only research-level telescopes regularly available to the public in the Western United States; and

WHEREAS, The City will require Chabot Space & Science Center to provide documentation for use of Councilmember Quan's Pay-Go funds; now therefore, be it

RESOLVED: That the City Council authorizes the grant of \$1,490.00 from Councilmember Quan's Pay-Go funds to Chabot Space & Science Center for Installation of the Historic Marker in Lafayette Square Park; and, be it

FURTHER RESOLVED: That the City Administrator is authorized to execute an appropriate grant agreement with Chabot Space & Science Center with the purposes of the grant, subject to approval as to form and legality by the City Attorney.
