

RESOLUTION IN SUPPORT OF ASSEMBLY BILL 1324 (SKINNER AND BONTA) AUTHORIZING ALAMEDA COUNTY TO INCREASE ANNUAL VEHICLE REGISTRATION FEES, WITH THE PROCEEDS TO BE USED TO FUND LOCAL INVESTIGATION AND PROSECUTION OF VEHICLE THEFT CRIMES

WHEREAS, current law allows counties to add a \$1 surcharge to vehicle registration (or \$2 for commercial vehicles) which is directed towards local programs to deter investigate, and prosecute vehicle theft; and

WHEREAS, AB 1324 would allow the Alameda County Board of Supervisors to raise its surcharge fee from \$1 to \$2, and from \$2 to \$4 for commercial vehicles; and

WHEREAS, AB 1324 would help Alameda County to address its increasing vehicle theft problem; and

WHEREAS, from 2011 to 2012, 12,622 cars were reported stolen in the county, a 17% increase from 2011 and overall 11% higher than the state of California; and

WHEREAS, AB 1324 would provide Alameda County with much-needed funds to prevent and combat the growing problem of vehicle theft; and

WHEREAS, as of May 5, 2013, Oakland has had 2,610 motor vehicle thefts; and

WHEREAS, as of May 5, 2013, Oakland has had 47 carjackings and 2,168 auto robberies; and

WHEREAS, given the level of car thefts in our City and the presence of robberies, it is in the City's best interest to support Senate Bill 1324 to further increase the vehicle registration fee to help fund investigations and persecution of vehicle theft crimes; now therefore be it

RESOLVED that the Oakland City Council supports California Assembly Bill 1324 and encourages the California State Legislature to accept it; and be it

FURTHER RESOLVED: That the City Council hereby directs the City Administrator and the City's legislative lobbyist to advocate for the above position in the California State Legislature.
