**RESOLUTION IN SUPPORT OF PROPOSITION 1, THE HOUSING PROGRAMS AND VETERANS' LOANS BOND, AND PROPOSITION 2, USE MILLIONAIRE'S TAX REVENUE FOR HOMELESSNESS PREVENTION HOUSING BONDS MEASURE**

**WHEREAS**, California, one of the largest economies in the world, is experiencing an extreme housing shortage and increase in homelessness; and

**WHEREAS**, California Proposition 1, the Housing Programs and Veterans' Loans Bond, initially introduced by Senator Jim Beall as Senate Bill 3, will appear on the November 2018 ballot and, if passed, would authorize \$4 billion in general obligation bonds for affordable housing-related programs, including, without limitation, loans and grants, in addition to housing loans for veterans; and

**WHEREAS**, Proposition 1 is supported by numerous organizations, businesses, community groups, officials, and municipalities, including East Bay Housing Organizations, State Building and Construction Trades Council of California, the City and County of San Francisco, the City of Alameda, and Oakland Mayor Libby Schaaf; and

**WHEREAS**, California Proposition 2, Use Millionaire's Tax Revenue for Homelessness Prevention Housing Bonds Measure, will appear on the November 2018 ballot and, if passed, would authorize the State of California to use revenue from 2004's Proposition 63, which imposed a 1% tax on income above \$1 million to be used for mental health services, to fund up to \$2 billion in revenue bonds for homelessness prevention housing for persons in need of mental health services; and

**WHEREAS**, Proposition 2 is supported by numerous organizations, community groups, and officials, including East Bay Housing Organizations and Habitat for Humanity CA; and

**WHEREAS**, No public funds shall be used in the campaign for or against Propositions 1 and 2; now, therefore, be it

2. **RESOLVED:** That the Oakland City Council hereby supports Propositions 1 and 2.


