Pursuant to Section 401 of the Charter, and the action of the Council at its October 17, 2006, closed session, the City Attorney has prepared a resolution authorizing and recommends settlement of the above-captioned matter, for the sum of Eighty Thousand Dollars and No Cents (\$80,000.00), payable to plaintiff Jacqueline Jackson and Stephen J. Gorog, Esq., her attorney of record.

This action arises out of a trip and fall accident based on a dangerous condition of a City sidewalk at 1411 East 31<sup>st</sup> Street on December 23, 2003. The settlement is recommended to avoid continued litigation expense and the risk of an adverse trial result and possibly greater economic exposure for the City.
