**RESOLUTION AUTHORIZING A GRANT OF \$2100 FROM COUNCILMEMBER NOEL GALLO'S GRAFFITI ABATEMENT MURAL AND GREEN WALL FUNDS TO THE UNITY COUNCIL, AS FISCAL SPONSOR FOR GIRL SCOUT TROOP #31262 AND THE RADICAL MONARCHS, FOR THREE MOSAIC TRASH CAN PROJECTS IN THE FRUITVALE NEIGHBORHOOD**

**WHEREAS**, on June 27, 2013, the City Council adopted a budget that set aside Anti-Graffiti Funds for Murals and Green Walls for the Oakland City Councilmembers to award at their discretion, subject to Council approval, in an effort to address graffiti within their districts; and

**WHEREAS**, the City-owned trash cans at the following locations are often tagged with graffiti:

- 1) E. 16th Street and 23<sup>rd</sup> Avenue
- 2) Foothill between 25th Avenue and 26<sup>th</sup> Avenue (next to the bus stop)
- 3) 29th Avenue and International; and

**WHEREAS**, The Unity Council is a 501c3 non-profit dedicated to community development through housing, educational services, economic development opportunities, and community programs; and

**WHEREAS**, The Unity Council will serve as the fiscal agent for Girl Scout Troop #31262 and The Radical Monarchs, who will develop three mosaics on the trash cans at E. 16th Street and 23<sup>rd</sup> Avenue, Foothill between 25th Avenue and 26<sup>th</sup> Avenue (next to the bus stop), and 29th Avenue and International, as part of a community-wide project to beautify the Fruitvale neighborhood; and

**WHEREAS**, The Unity Council will participate in the City's Adopt-A-Spot program in which they will commit to maintaining the trash cans following the installation of the mosaic upon trash cans; and

**WHEREAS**, Councilmember Noel Gallo wishes to grant a portion of his Graffiti Abatement Mural and Green Wall Funds to The Unity Council as the fiscal agent for Girl Scout Troop #31262 and The Radical Monarchs to fund a mosaic on the exterior of three trash cans located at the following locations in the Fruitvale neighborhood:

- 1) E. 16th Street and 23<sup>rd</sup> Avenue
- 2) Foothill between 25th Avenue and 26<sup>th</sup> Avenue (next to the bus stop)
- 3) 29th Avenue and International; and

**WHEREAS**, in conformance with City requirements, The Unity Council, Girl Scout Troop #31262 and The Radical Monarchs will provide documentation for the use of the Councilmember's Graffiti Abatement Mural and Green Wall Funds, including any permits required and permission from the property owner to install the mosaics; now, therefore, be it

**RESOLVED:** That the City Council authorizes the grant of \$2100 from Councilmember Noel Gallo's Graffiti Abatement Mural and Green Wall funds to The Unity Council as the fiscal agent for Girl Scout Troop #31262 and The Radical Monarchs for three mosaic trash cans in the Fruitvale neighborhood in Oakland, located at the following locations:

- 1) E. 16th Street and 23<sup>rd</sup> Avenue
- 2) Foothill between 25th Avenue and 26<sup>th</sup> Avenue (next to the bus stop)
- 3) 29th Avenue and International; and be it

**FURTHER RESOLVED:** That the City Administrator is authorized to execute a grant agreement with The Unity Council, as fiscal sponsor for Girl Scout Troop #31262 and The Radical Monarchs, for the above purpose, subject to approval as to form and legality by the City Attorney.


