INTRODUCED BY VICE MAYOR DESLEY BROOKS

RESOLUTION AUTHORIZING VICE MAYOR DESLEY BROOKS TO TRAVEL TO SEATTLE, WASHINGTON TO ATTEND THE NATIONAL LEAGUE OF CITIES LEADERSHIP ACADEMY ON LOCAL ECONOMIC COMPETITIVENESS IN A GLOBAL ERA CONFERENCE FROM APRIL 19-21, 2011

WHEREAS, Vice Mayor and Council Member Desley Brooks, is the City of Oakland's delegate to the National League of Cities, and she wishes to represent the City of Oakland at the National League of Cities Leadership Academy: Local Economic Competitiveness in a Global Era Conference in Seattle Washington, from April 19, 2011 to April 21, 2011; and

WHEREAS, pursuant to City Council Resolution No. 82800 C.M.S. approved by Council on June 1, 2010, which establishes a policy that Councilmembers, who seek Council approval for travel, shall indicate whether City funds will be used when travel involves airline transportation and lodging, and shall provide an estimate of the cost of airline, lodging, per diem and conference fees when City funds are used and the source of City and/or Redevelopment Agency funding that will be used to cover the travel costs; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the estimated cost of transportation (including airfare and taxis) is \$450.00, of per diem is \$168.00 for 3 days, and of conference estimated registration fees is \$400.00; and

WHEREAS, in compliance with City Council Resolution No. 82800 C.M.S., the source of City funding that will be used to cover the travel costs will be from City Council Contingency Project funds; and

WHEREAS, Vice Mayor and Council Member Desley Brooks seeks Council approval of the afore mentioned estimated costs to travel to Seattle, Washington, to attend the National League of Cities Leadership Academy on Local Economic Competitiveness in a Global Era Conference in Seattle Washington, from April 19, 2011 to April 21, 2011; now, therefore, be it
