OAKLAND CITY COUNCIL RESOLUTION NO. 88991 C.M.S.

INTRODUCED BY COUNCILMEMBER KALB

RESOLUTION IN SUPPORT OF CALIFORNIA STATE ASSEMBLY BILL 328 THAT WOULD REDIRECT A PORTION OF COST SAVINGS AT THE CALIFORNIA DEPARTMENT OF CORRECTIONS AND REHABILITATION TO EVIDENCED-BASED REENTRY HOUSING

WHEREAS, formerly incarcerated people face risks of homelessness and are a major factor contributing to California's homelessness crisis; and

WHEREAS, reducing the population of California prisons began in 2011 with Governor Brown's realignment which transferred a number of incarcerated people from state prisons to local jails; and

WHEREAS, Proposition 47, in 2014, and Proposition 57, in 2015, continued to reduce the prison population by allowing incarcerated people to qualify for shorter sentences; and

WHEREAS, the California Legislature recently limited sentencing enhancements through a number of bills including SB 1393 in 2018 and SB 136 in 2019; and

WHEREAS, Governor Newsom ordered the release of more than 3,500 non-violent offenders to mitigate the spread of COVID-19; and

WHEREAS, the Legislative Analyst's Office estimates that the projected prison population changes will close prisons and reduce costs at the California Department of Corrections and Rehabilitation (CDCR) by a total of \$1.5 billon by 2024-2025; and

WHEREAS, formally incarcerated people are 27 times more likely have unstable housing than the general public and 10 times more likely to become homeless and 50 percent of people who are homeless report a history of incarceration; and

WHEREAS, California State Assembly Bill 328 would redirect a portion of the savings from the CDCR budget to the Reentry Housing and Workforce Development Program to provide permanent supportive housing and workforce training to formerly incarcerated people who are homeless or at risk of homelessness; and

WHEREAS, the Program will allocate funding to counties, community-based organizations and homeless continuums of care on a competitive basis; and

WHEREAS, as 30,000 people are expected to leave prison annually over the next five years, the Program will shield thousands from homelessness; now, therefore, be it

RESOLVED: That the City Council hereby endorses AB 328 and urges the California State Legislature and Governor Gavin Newsom to support its enactment into law.
