

NOTICE AND DIGEST

ORDINANCE: (1) ESTABLISHING THE CITY OF OAKLAND'S (CITY) POLICY PROHIBITING THE CITY'S USE OF NEONICOTINOID PESTICIDES (NEONICOTINOIDS) TO PROTECT HONEY BEES AND OTHER POLLINATORS; (2) URGING THE ADOPTION OF STATE AND FEDERAL RESTRICTIONS ON NEONICOTINOIDS; AND (3) URGING RETAILERS OPERATING IN THE CITY OF OAKLAND TO NOT SELL NEONICOTINOIDS

This ordinance establishes a policy (policy) prohibiting the City from using Neonicotinoid pesticides. It also requires the City to urge state and federal legislators to take action to regulate Neonicotinoid pesticides and for the City to inform local public agencies and retailers about the policy.
