President Reid and Members of the City Council:

Pursuant to Section 401 of the Charter, the City Attorney has prepared and requests your approval of a resolution authorizing compromise and settlement of the above-entitled action. Due to the risk of an adverse jury verdict under the circumstances settlement is recommended in the sum of Seventy-five Thousand Dollars and No Cents (\$75,000.00). Fifty Thousand dollars and No Cents (\$50,000) shall be payable to Plaintiff Jamil Kaludi and Andrew Wolff, his attorney. Twenty-five Thousand Dollars and No Cents (\$25,000) shall be paid into a medical escrow account.


