

**INTRODUCED BY COUNCIL PRESIDENT LYNETTE GIBSON MCELHANEY**

**RESOLUTION PURSUANT TO THE COUNCIL'S RULES OF PROCEDURE (RESOLUTION NO. 82580 C.M.S.) TO CONFIRM THE CITY COUNCIL PRESIDENT'S APPOINTMENTS OF THE MEMBERS AND CHAIRPERSONS OF THE PUBLIC WORKS, FINANCE AND MANAGEMENT, COMMUNITY AND ECONOMIC DEVELOPMENT, LIFE ENRICHMENT, PUBLIC SAFETY, RULES AND LEGISLATION, AND EDUCATION PARTNERSHIP COMMITTEES OF THE CITY COUNCIL**

WHEREAS, Rule 4 of the Council's Rules of Procedure Resolution No. 82580 C.M.S. provides that the Council President shall appoint all committees and committee chairs subject to confirmation by a majority of the Council; and

WHEREAS, Rule 4 further provides that the subject matter standing committees of the Council shall consist of the following: Public Works, Finance and Management, Community and Economic Development, Life Enrichment, Public Safety, Rules and Legislation and Education Partnership; and

WHEREAS, Rule 4 provides that the Council may establish such other ad hoc or standing committees as it deems appropriate (e.g. City/Port Liaison Committee and the Education Partnership Committee) and that a majority of the members of the Council may direct the appointment of a committee by the Council President; now therefore be it



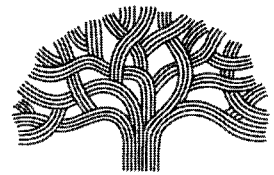
