SUBJECT: **Public Hearing on the Assessment of Liens for Delinquent Real Property Transfer Taxes**

---

**SUMMARY**

On March 7, 2005, pursuant to Chapter 4.20 of the Oakland Municipal Code, an administrative hearing for delinquent Real Estate Transfer Taxes was held to hear protests and resolve any inconsistencies or inequities raised by property owners prior to the public hearing before City Council.

A resolution has been prepared confirming the placement of liens on 15 accounts and authorizing the subsequent assessment for all fees and charges, should they remain unpaid at the time of the City's submission to the County Assessor.

**FISCAL IMPACT**

Property owners owe the City delinquent real property transfer taxes and administrative fees for the accounts not resolved at the March 7, 2005 administrative hearings. Failure to place a lien to recover the tax will result in an estimated loss of \$80,505 revenue to the City's General Fund.

**BACKGROUND**

The City notified property owners of the City's intent to record a lien against their property. No cases were resolved and removed from the list of delinquent properties.

A resolution has been prepared confirming the placement of liens on 15 accounts and authorizing the subsequent assessment for all fees and charges.






