WHEREAS, Mr. Robert Glaze attended Chabot College from 1973-1975, and was employed by Kirsh Engineering from 1973-1977, admitted into the Secret Service Training Program in 1984, and has been a member of The California Electrical Contractors Association since 1979, and

WHEREAS, Mr. Robert Glaze was Employed by the City of Oakland as a Part Time employee from 1970-1973 as a Children's Fairyland Helper/Attendant, and as a Permanent Employee in 1973, where he held several positions, including Program & Maintenance Director, Telecommunications Supervisor, Information Systems Manager, Customer Services Manager, Chief Technology Officer, Chief Information Officer, and Director, and;

WHEREAS, Mr. Robert Glaze, was named OIT Employee of the Year in 2000, was recognized with an "Oakland's Bob Glaze Day", on December 29, 2006, served on the PTI Telecommunications and Information Council from 2003-2009, and served on the San Leandro City Council from 1984 - 1992, and became the youngest Vice Mayor in San Leandro History, and;

WHEREAS, Mr. Robert Glaze, while serving on numerous commissions and boards, including the Alameda County Transportation Committee, The Alameda County Waste Management Authority, the Alameda County Training & Employment Governing Board, the League of California Cities - Employee Relation Committee, The Bay Conservation and Development Commission, Congestion Management Authority as an alternate member, is married to his lovely wife Teresa, since 1978, and is the proud father of two children, Crystal, and Brian, so, now, therefore, be it:


