

**RESOLUTION TO ADOPT THE 2022-2025 STRATEGIC INVESTMENT  
PLAN OF THE OAKLAND FUND FOR CHILDREN AND YOUTH AS  
APPROVED BY THE PLANNING AND OVERSIGHT COMMITTEE**

**WHEREAS**, the Kids First! Initiative amended the City Charter and established the Oakland Fund for Children and Youth (hereafter known as "OFCY") to support direct services for children and youth; and

**WHEREAS**, the Charter Amendment stipulates that the Planning and Oversight Committee ("POC") submit to the City Council for its adoption a three-year Strategic Investment Plan; and

**WHEREAS**, the POC and its staff gathered and reviewed current demographic, economic, education, and community health and safety data, developed and managed the process through an ad-hoc strategic planning subcommittee, hosted provider, community, and youth input engagement events throughout the City, reviewed current funding strategies and program's impact, and conducted research into effective practices to assess priority areas for the strategic plan; and

**WHEREAS**, the POC and community members selected high priority strategies to include Social Emotional Well-being in Early Childhood & Family Resource Centers and Parent Engagement to support the Healthy Development of Young Children; Comprehensive School-Based Afterschool at Elementary Schools, Comprehensive School-Based Afterschool at Middle Schools, Middle School Engagement, Wellness, and Transitions, & High School and Post-Secondary Student Success to support Children's Success in School; Youth Leadership and Development, Summer Academic and Enrichment Programs, & Violence Prevention Programming to support Youth Development and Violence Prevention; and Career Access and Employment for Opportunity Youth & Career Access and Employment for Youth in School to support Transitions to Adulthood; and

**WHEREAS**, the high priority strategies identify specific age ranges, goals, intended outcomes, and community needs; and

**WHEREAS**, these high priority strategies have been presented to City Council in the 2022-2025 Strategic Investment Plan; and

**WHEREAS**, the 2022-20225 Strategic Investment Plan was approved by the Planning and Oversight Committee on October 27, 2021; now, therefore, be it

**RESOLVED:** That the City Council hereby adopts the 2022-2025 Strategic Investment Plan of the Oakland Fund for Children and Youth and Planning and Oversight Committee as approved by the Planning and Oversight Committee on October 27, 2021.


