INTRODUCED BY COUNCILMEMBER NOEL GALLO

RESOLUTION DESIGNATING COUNCILMEMBER NOEL GALLO AS THE CITY OF OAKLAND'S ALTERNATE VOTING DELEGATE TO REPRESENT THE CITY OF OAKLAND AT THE ANNUAL LEAGUE OF CALIFORNIA CITIES' 2023 CONFERENCE SEPTEMBER 20-22, 2023, IN SACRAMENTO CALIFORNIA, AND AUTHORIZING TRAVEL AND REIMBURSEMENT OF NECESSARY EXPENSES IN THE AMOUNT OF \$1,500 FOR ATTENDANCE AT THE 2023 CONFERENCE (REGISTRATION FEES, HOTEL, MILEAGE AND PER DIEM) FROM THE CITY COUNCIL CONTINGENCY FUND

WHEREAS, the City of Oakland is a Member City of the League of California Cities; and

WHEREAS, the Bylaws of the League of California Cities, Article V, Section 3(a) states: "Designation. Each Member City may, with the approval of the city council, designate a city official as the city's designated voting delegate and, in the event that the designated voting delegate is unable to serve in that capacity, up to two alternate voting delegates;" and

WHEREAS, the City Council's Rules of Procedure, Rule 6 (Resolution No. 88266 C.M.S.) states that "the President of the Council shall recommend appointments to regional and local boards and agencies, as appropriate, subject to confirmation by Council resolution;" and

WHEREAS, the Council President recommends the appointment of Noel Gallo as the City of Oakland's Alternate Voting Delegate for the Annual Conference and Expo of the League of California Cities in Sacramento, California from September 20-22, 2023 (the Conference); and

WHEREAS, at the Conference, a cross-section of California city elected officials, mayors, council members, city managers, city clerks, city attorneys, fiscal officers and other city staff will be engaged in detailed discussions with over 100 speakers in best practices and current policy issues affecting cities such as Oakland included but not limited to housing, homelessness, sustainability, climate resilience, and transportation; and

WHEREAS, Resolution No. 82800 C.M.S. approved by Council on June 1, 2010, establishes a policy that Councilmembers, when seeking Council approval for travel, shall indicate whether City funds will be used when travel involves transportation and lodging and shall provide an estimate of the cost of transportation, lodging, per diem and conference fees when City funds are used as well as the source of City funding that will be used to cover said travel expenses; and

WHEREAS, in compliance with Resolution No. 82800 C.M.S., the costs are estimated to be \$1,500 (including Councilmember Gallo's conference registration fees, hotel, mileage and per diem); and

WHEREAS, Councilmember Noel Gallo seeks Council approval of the aforementioned estimated costs to travel to and attend the Conference; now, therefore, be it

RESOLVED: That Councilmember Noel Gallo is hereby designated as the City of Oakland's Alternate Voting Delegate for the Conference; and be it

FURTHER RESOLVED: That all expenses incurred for said travel are hereby authorized.
