The City Council authorized settlement in the amount of \$324,000. The City's insurance carriers will pay \$300,000 and the City will pay \$24,000.

Facts of the Case:

This case stems from incidents that occurred in 1996. The seven plaintiffs contend that Oakland police officers violated their civil rights by falsely arresting them and subjecting them to excessive force and that they were prosecuted and incarcerated based on testimony and evidence presented by one or more of the four police officers who subsequently were terminated by the City. After the City terminated the four officers, the District Attorney indicted them on multiple criminal counts, including but not limited to, perjury, fabrication of evidence and assault and battery. The District Attorney dismissed and overturned criminal convictions of the plaintiffs whose convictions were based on testimony of the officers.

The City Council authorized settlement in the amount of \$20,000.

Facts of the Case:

Plaintiff contends that he was arrested on September 13, 2001, based on false and/or misleading information that Oakland Police Department investigators submitted to the judge who issued a warrant for plaintiff's arrest. The affidavits that Oakland Police Department submitted to the judge erroneously stated that plaintiff had the knowledge and materials to produce explosive devices and that he had made threats to harm people.

Plaintiff sustained head and leg contusions when he was tackled to the ground near the carport area of his apartment building and he also asserted that he suffered psychological trauma as a result of the arrest. His medical expenses totaled \$18,000.
