

RESOLUTION NO. 90001 C.M.S.

RESOLUTION AMENDING RESOLUTION NO. 89376 C.M.S., WHICH AWARDED GRANTS TO COMMUNITY SERVICE PROVIDERS, TO ADD FAITH IN ACTION EAST BAY, A CALIFORNIA NONPROFIT CORPORATION, AS THE FISCAL SPONSOR FOR THE GRANTEE "AT THY WORD MINISTRIES" FOR AN AMOUNT NOT TO EXCEED FIFTY THOUSAND DOLLARS (\$50,000).

WHEREAS, on June 24, 2021, the City Council adopted the Fiscal Year (FY) 2021-23 biennial budget (Resolution No. 88721 C.M.S.), which appropriated funds for the expenditures proposed by said budget; and

WHEREAS, in May and June 2022, the City Council reviewed the City's revenues and expenditures as part of the midcycle budget review process and, on June 30, 2022, adopted FY 2022-23 Midcycle Budget Adjustments to balance the FY 2021-23 biennial budget (Resolution No. 88721 C.M.S.); and

WHEREAS, on July 22, 2022, the City Council adopted Resolution No. 89376 C.M.S., awarding grant agreements to community service providers, including a grant for Fifty Thousand Dollars (\$50,000) to At Thy Word Ministries; and

WHEREAS, Resolution No. 89376 C.M.S did not contain the legal names and/or fiscal sponsors for the Grantees and does not provide the authority to execute a grant agreement with the entities; and

WHEREAS, At Thy Word Ministries is a nonprofit engaged in community services that requires a fiscal sponsor in order to accept these grant funds and Faith in Action East Bay, a registered 501(c)(3) nonprofit corporation, has agreed to be the fiscal sponsor for At Thy Word Ministries for this purpose; and

WHEREAS, At Thy Word Ministries will use the funding to distribute food to community members in East Oakland; and

WHEREAS, the City Council wishes to expedite the issuance of this grant to improve the lives of Oakland community members; now, therefore, be it

RESOLVED: That Resolution No. 89376 is amended to add Faith in Action East Bay as the fiscal sponsor for At Thy Word Ministries; and be it

FURTHER RESOLVED: That carryforward from FY22-23 to FY23-24 will be allocated to Faith in Action East Bay as the fiscal sponsor for At Thy Word Ministries; and be it

FURTHER RESOLVED: That all other provisions of Resolution No. 89376 C.M.S. remain unchanged, except for those changes made by Resolution No. 89433 C.M.S., Resolution No. 89601 C.M.S., and Resolution No. 89635, C.M.S.; and be it

FURTHER RESOLVED: That this Resolution shall take effect immediately upon its passage.


