

## OAKLAND CITY COUNCIL

Resolution No. 83821 C.M.S.

INTRODUCED BY VICE MAYOR NANCY NADEL

**A RESOLUTION: (1) AUTHORIZING AN IMMEDIATE GRANT OF \$2,500 FROM COUNCILMEMBER NANCY NADEL'S PRIORITY PROJECT FUNDS TO THE KOREATOWN/NORTHGATE COMMUNITY BENEFIT DISTRICT TO OFFSET EXPENSES INCURRED FOR THE PUBLIC RIGHT OF WAY BEAUTIFICATION PROJECT ON TELEGRAPH AVENUE FROM 20<sup>TH</sup> TO 27<sup>TH</sup> STREET, AND (2) AMENDING RESOLUTION NO. 80283 C.M.S., WHICH ALLOCATED \$60,000 OF COUNCILMEMBER NADEL'S PRIORITY PROJECT FUNDS TO THE CITY'S NEIGHBORHOOD COMMERCIAL REVITALIZATION PROGRAM TO BE USED TO HIRE AN EXECUTIVE DIRECTOR FOR THE WEST OAKLAND MAIN STREET PROGRAM TO MAKE THE PRIORITY PROJECT FUNDS AVAILABLE FOR OTHER USES BY COUNCILMEMBER NADEL**

**WHEREAS**, on December 5, 2006, the City Council, approving Resolution No. 80283 C.M.S., authorized apportionment of \$60,000 of Councilmember Nadel's Priority Project funds to the Community Economic Development Agency (CEDA) Neighborhood Commercial Revitalization Program for the purpose of hiring an Executive Director to develop a project plan and perform other duties during the initial planning stages of the West Oakland Main Street Project (WOMS); and

**WHEREAS**, an Executive Director was not hired and no work was been performed the WOMS project following approval of Resolution No. 80283 C.M.S.; and

**WHEREAS**, the City did not use the above-described allocation of Councilmember Nadel's Priority Project funds, therefore, she wishes to rescind the allocation and use her priority project funds for other purposes such as a grant to the KoreaTown/Northgate Community Benefit District to reimburse them for their expenses incurred undertaking the beautification work; and

**WHEREAS**, Councilmember Nancy Nadel wishes to use \$2,500.00 of her Priority Project Funds to help offset expenses incurred by the KoreaTown/Northgate Community Benefit District for the public right of way beautification project on Telegraph Avenue from 20<sup>th</sup> Street to 27<sup>th</sup> Street; now be it

**REVOLVED:** That the City Council authorizes the use of \$2,500.00 of Councilmember Nancy Nadel's Priority Project Funds for a grant to offset expenses incurred by the KoreaTown/Northgate Community Benefit District to offset their expenses incurred for the public right of way beautification project on Telegraph Avenue from 20<sup>th</sup> Street to 27<sup>th</sup> Street; and

**FURTHER RESOLVED:** The City Administrator is hereby authorized to enter into a grant agreement with the KoreaTown/Northgate Community Benefits District in the amount of \$2,500.00 for the above purposes from Councilmember Nancy Nadel's Priority Project Funds Account No. 78811, and Project No. P292210; and be it

**FURTHER REVOLVED:** That the City Council hereby amends Resolution No. 80283 C.M.S., passed December 5, 2006, which allocated Councilmember Nadel's Priority Project funds to the City's Neighborhood Commercial Revitalization Program, and authorizes reallocation of all remaining such priority project funds to Councilmember Nadel's Priority Project Funds Account No. 78811, so that Councilmember Nadel may use these priority project funds for other purposes.
