## ORDINANCE NO. 12925 C.M.S.

An Ordinance Adding Section 3.08.040 to Chapter 3.08 of the Oakland Municipal Code, Entitled "Elections," to Authorize the City Council to Call a Special Municipal Election on July 21, 2009

WHEREAS, the California Constitution, Article XI, section 5(b) grants chartered cities the power to provide in their charter for the conduct of city elections; and

WHEREAS, Oakland City Charter section 1103 provides that all elections and procedures relating thereto shall be in accordance with the applicable provisions of state law, except as may be otherwise provided by ordinance or the City Charter; and

WHEREAS, the Oakland Municipal Code Chapter 3.08 entitled, "Elections," includes provisions that the City Council has adopted to govern municipal elections; and

WHEREAS, the City Council desires to amend Chapter 3.08 to add a new section 3.08.040 that will authorize the Council to call a special election on July 21, 2009, provided that such election date is not less than 88 days before the date on which the Council calls the election; and

WHEREAS, the City Council further desires to have the option to utilize alternative voting procedures, including but not limited to mail ballot voting, electronic voting, and extended voting periods in conducting special elections in addition to traditional in-person voting at polling places;

## Now Therefore the City Council of the City of Oakland does ordain as follows:

Section 1. The City Council finds and determines the foregoing recitals to be true and correct and hereby adopts and incorporates them into this Ordinance.

Section 2. The Municipal Code hereby is amended to add, delete, or modify sections as set forth below (section numbers and titles are indicated in **bold** type; additions are indicated by underscoring and deletions are indicated by strike through type; portions of Chapter 3.08 what are not cited or shown in underscoring or strike-through type are not changed.

Section 3. New Section 3.08.040 hereby is added to Chapter 3.08 of the Oakland Municipal Code.

## **ARTICLE 1. General Provisions**

## Section 3.08.040 Special Municipal Elections

The City Council shall have the power to call a special municipal election by resolution for July 21, 2009, provided that the election date must be at least 88 days after the date that the City Council calls the election and, notwithstanding any other provision of the State of California Elections Code. Further, the City Council shall have the power to utilize alternative voting procedures, including but not limited to mail ballot voting, electronic voting, and extended voting periods to conduct such special election, in addition to traditional in-person voting at polling places.
